ANNOUNCEMENT:

The West Leeds Motor Club Ltd. will organise a National Trial on Sunday 11th September 2022 for solo motorcycles, held under the National Sporting Code, Standing Trials Regulations of the ACU, the following Supplementary Regulations and any final instructions issued for the meeting. Three classes for Adults: White Rose Course, 50/50 & Clubman's course. (There will be dual sections to accommodate Clubman and 50/50 course riders).

COVID -19:

Individuals need to take responsibility for their own safety and exercise judgement as appropriate.

The event will be run under the current recommendations issued by the Government and the ACU and must be adhered to. Anyone who has contracted coronavirus, exhibited symptoms, been in contact with someone who has been infected with the virus, or requested to self-isolate in a ten-day period prior to the event taking place shall not travel to or participate/officiate at the event and will follow Gov.uk guidance/advice as appropriate.

ELIGIBILITY:

Open to all members of ACU Affiliated Clubs. All riders and passengers must hold a current ACU / SACU Trials Registration card or ACU/SACU competition licence. Any rider or passenger from another FMN MUST produce a licence issued by their FMN together with start permission and proof of personal accident Insurance.

MACHINES:

Motorcycles as per NSC Appendix D Category 1, Group A1 Solos and TSR 8.

START/VENUE:

Start 10am at CAM HEAD, NR. HAWES. (A684 through Gayle). NORTH YORKSHIRE, **what3 words address noisy.kipper.bluff**. First two riders will start at 10.01 and then in pairs at one minute intervals. Clubman riders will start first followed by White Rose riders and 50/50 riders last.

ENTRIES:

Enter by post or online via ACU Event Entry System. (Ensure your details on the ACU website are 100% correct as this will be the only method of contact) Entries will close 4/09/2022 12:00. Only those who fulfil the Eligibility criteria will be allowed to enter. You will be notified of your entry acceptance by email. Entry Fee(s): - £35. Note in the event of cancellation of event or a rider cancelling their entry the ACU will make a £3 surcharge for each rider entered via the ACU Event Entry System.

There will be an entry limit of 185 riders. No late or telephone entries will be accepted. Riding numbers will be allocated in reverse order of receipt, (early entry = late number) in 3 groups, Clubman riders, 50/50 riders and White Rose riders. COURSE:

The course will consist of one lap and 40 sections in and around Hawes accessed by public highway.

The Time limit for the event will be allocated with your start time. Time penalties will be incurred 1 mark per minute up to a maximum of 20 minutes for late starting and late finishing and thereafter will be disqualified.

A part of the course will be passing by a Red Squirrel Conservation area at grid ref SD827 872 for approx 1 mile. There will be signs warning of this area.

Please ride with extreme care at this point as there may also be young children about.

METHOD OF MARKING: As per TSR22b; No-stop. Ties will be resolved as per TSR23.

PROTESTS: As per the National Sporting Code of the ACU section10.04.

GENERAL:

Two Cans of Petrol will be necessary. Fill up after first leg at car park. A petrol stop area will be signed, you will pass this on the road to the start, at which you may deposit one can of petrol; the course will pass this area. (There will be NO transport of fuel around the course). There will be a catering van at the start area for refreshments.

The use of GoPro or similar recording equipment either worn or on machine is expressly forbidden.

All machines must display a registration plate.

NO NUMBER PLATE NO RIDE

RTA COVER:

Through the ACU Road Traffic Act Insurance Scheme, 3rd Party RTA insurance will be available at the start for competitors who are able to meet the requirements specified by the insurance company. (No additional charge will be levied for this cover). The machine which is entered and competed on must be suitable and proper for its purpose, shall be road legal and that it will comply with the regulations in respect thereof.

ENTRY DECLARATION: I the undersigned apply to enter the event described above and in consideration thereof: -
